

Terms of Reference (ToR)

for procurement of Consulting Companies, Agencies, OR Team of Individual Experts for women in Beekeeping sector in Peja Region

I. Background:

EKW invites interested Consultants for Technical Study for improving Women in Beekeeping Sector, in Kosovo under the project "Empowering women and Communities living in rural Kosovo" funded by We Effect, Sweeden

EcoKosWomen (EKW) is a distinguished non-governmental organization headquartered in Prishtina, founded in July 2019. EKW is profoundly committed to driving social progress across agriculture, environmental sustainability, and socio-economic realms, placing a strong emphasis on empowering women in agriculture, tackling environmental challenges, and advocating for gender equality. Through its initiatives, EKW has become an encouragement of hope and progress for women in rural areas, offering them the tools and opportunities to improve their lives and their communities.

The beekeeping sector in Kosovo plays a vital role in agricultural productivity, biodiversity conservation, and rural economic development. Despite its potential, challenges such as climate change, disease management, market access, and production capacity remain. To support sustainable growth and policy development, a comprehensive assessment of the sector is required.

Women in Kosovo are increasingly engaging in beekeeping, a field traditionally dominated by men, as a means of economic empowerment, fostering social cohesion, and preserving cultural heritage. With the support of various initiatives, training programs, and funding opportunities, women beekeepers are establishing their businesses, improving their livelihoods, and strengthening their communities.

In this context EKW recognizes the need for a technical study to understand the challenges and opportunities faced by women, farmers in beekeeping. This report aims to explore knowledge levels, attitudes, and infrastructure capacities, ensuring that interventions and support programs are effectively tailored to women's needs in this sector.

The proposed report aims to gather data through a multifaceted approach, including, literature review and secondary data analysis, fieldwork, surveys, interviews, and focus group discussions and SWOT analysis to identify strengths, weaknesses, opportunities, and threats. By examining the knowledge gaps, perceptions, and infrastructural limitations, EKW intends to identify the key challenges and opportunities that rural women beekeepers face. The goal is to support rural women in embracing modernized agricultural practices and engaging in beekeeping, thus contributing to their economic independence and the sustainable development of rural communities in Kosovo. From May 2024, EKW implements the project "Empowering



women and communities living in rural Kosovo"; that is supported by Swedish development organization We Effect, funded by SIDA.

II. Objective of the Assignment:

Objective of this assignment is to analyze the current state of the beekeeping sector In Peja Region and social and economic landscaper and based on this analysis and building upon the cooperative -based model, the assignment will provide business plans that explore the opportunities for the expansion of the existing business.

The objective will be achieved by:

- a) Assessing the socio-economic landscape of existing women in beekeeping in Peja Region and identifying the interest of these women in establishment of associations like businesses in production of honey and honey products.
- b) **Conducting socio-economic development study**, assessing the current economic condition of the targeted women in Peja region and foreseen state after applying the interventions elaborated with the recommended business plan for beekeeping businesses. The study should provide a clear gender equality and women empowerment perspectives.
- c) **Development of business plan** for the proposed businesses. Additionally, to create business plan focused on establishing a local store to promote and sell honey and honey products produced by women.
- d) Evaluate and **analyze current MAP and planting nectar** producing plants with clear perception of the available areas (private and national/municipal), including the development of the business plan for planting the MAPs
- e) Evaluate and **analyze current situation of the transport of bees to mountain areas** with a clear picture how the vehicle for transport of bees should look like, securing that the same vehicle can be used by all women beekeepers at the same season, including development of the business plan for purchasing the vehicle.
- f) Identify key challenges, obstacles, including climate conditions, pests, diseases, and access to inputs.
- g) **Preparing a detailed full size project proposal** based on the findings of the social development study, the economic development study and the business plans.

III. Scope of the work

The selected consulting company OR agency, OR team of individual experts must ensure that the designated expert on economic development, and the expert responsible for business plan development are actively present in the field. These experts should take the lead in discussions with the stakeholders in Peja region, facilitating meaningful engagement and ensuring thorough data covered with the studies and business plans.

This task will enable experts to gain a comprehensive understanding of the current state of the beekeeping sector, allowing them to identify a wide range of opportunities. Once these



opportunities are recognized, potential models for establishing businesses should be outlined, with the most suitable ones drafted in detail. These selected models should then be further discussed with beekeeping women farmers to gather their feedback, assess their willingness to participate, and address any concerns. Additionally, all necessary social and economic data should be collected to ensure the development of a well-founded and detailed business plan.

• Socio-economic study for potential establishment of cooperative-like business for production honey and honey products.

Socio-economic study should contain the following content:

- Introduction
- Methodology
- Current socio-economic conditions of the women farmers in Peja region in honey and honey products.
- Results of the field consultation with stakeholders
- Available options for addressing the needs and challenges
- Selection and technical elaboration of the best available model
- Vision [that will be achieved if we apply the best available option]

Socio-economic studies should serve as an input for the development of business plans.

Development of business plan

Based on the socio-economic studies and selected best available model for establishment of cooperative-like businesses, the team of experts should prepare detailed business plan.

The plan should be made building upon the results of the market assessment that provides clear overview of the market size, market share, target customers, potential customers, their behaviors, and competitive landscape.

Once the foundation of the market assessment is clarified, the business plan should present the key findings of the market dynamics, emerging trends, potential value chain, and scenarios for the future market conditions based on the trends-based risks and assumptions.

The business plan should specify:

- which women farmer will be included in the given cooperative-like business,
- how each of them will be supported by the project (assets, equipment, marketing, training)
- how she will contribute to the cooperative-like model,
- what will be investment for each women farmer (further specified in the foreseen project application),
- what will be the annual profit,
- what will be the intended payback period, and
- what will be difference between the current and foreseen economic parameters for each woman farmer after completion of the intervention.



The scope of work considers implementation of the following main tasks:

- Explore knowledge levels, attitudes, and infrastructure capacities, ensuring that interventions and support programs are effectively tailored to women's needs in this sector.
- Assess market conditions, supply chains, and export potential.
- Review existing policies, regulations, and support mechanisms.
- Data analysis from the survey, interviews and focus groups
- Provide recommendations for improving productivity, sustainability, SWOT analysis and market integration.

III. Duty travel &accommodation

IV. Coordination & Reporting:

The consultant/team will work closely with EKW's Project Manager and report to the manager.

V. Qualification Requirements:

The team should have at least two key experts.

Key Expert 1: Economic Development

- University degree in Agriculture, Veterinary or related fields.
- At least 10 years' experience in conducting socio-economic assessment and development of business plan in rural contexts, preferably with women farmers.
- Senior experience in qualitative and quantitative research methodologies.
- Experience with beekeeping.

Key Expert 2: Business plan and social inclusion

- University degree in Agriculture, Veterinary or related fields.
- At least 7 years' experience in conducting surveys, interviews, and focus groups in rural contexts, preferably with women farmers.
- Experience in organizing and conducting trainings, working groups and fieldwork.
- Experience with women beekeepers.

Preparing a detailed full size project proposal

Based on the findings of the socio-economic plan and the business plan for each of the proposed cooperative-like businesses, the team of experts should develop a project proposal for a full-size project that will secure the vision specified in the socio-economic plan is achieved.

The project proposal is expected to incorporate the following chapters:

- Relevance of the action
- Target groups and final beneficiaries
- Foreseen improvement
- Intervention logic
- Description of activities
- Methodology
- Equipment, materials, and supplies
- Coordination with complementary initiatives
- Role and participation of actors and stakeholders
- Monitoring and evaluation
- Visibility plan
- Action plan (table)
- Sustainability of the project interventions
- Budget



The final report should be in English and Albanian.

VI. Application Procedure:

VII. Evaluation of the offers:

The incomplete applications or applications received after the deadline for submission will not be taken into consideration.

The evaluation of offers will be based on the "best value for money principle" by using a weighted scoring method to evaluate the combination of the applicants' qualification (70%) and financial proposal (30%).

The most responsive/compliant/acceptable proposal, having received the highest combined score out of a weighted technical and financial evaluation specific to the solicitation, will be selected. The offers will be evaluated based on the technical criteria and financial criteria.

1. Technical evaluation (70%): [1+2+3/30% + 30% + 10% = 70%]

a) Evaluation of professional experience (relevance, 30%). Expertise and experience: Number of years of experience in the fields relating to Terms of Reference; Similar assignments.

b) Evaluation of Methodology (30%):



c) Evaluation of Familiarity with beekeeping, women in beekeeping (10%)

Only the candidates who will reach the threshold of 60% of the technical qualification will be considered for the financial evaluation.

2. Financial evaluation (30%)

Based on the formula: 30 * (Lowest Price / Proposed Price).

VIII. Terms of payment:

Due to the expected value and duration of the contract, this assignment considers payment to be realized in two instalments 25 % after the contract signature and 75 % upon approval of the final report deliverables described with this TOR.
